Postdoc at Plant Molecular Biology Laboratory (dr Yamada Group) at the
MALOPOLSKA CENTRE OF BIOTECHNOLOGY**

Eligible contestants must meet the requirements in art. 109, which was established in 27.07.2005 followed by the Law on Higher Education (Dz. U. nr 164, poz. 1365, z późn. zm.) and meet the following qualification criteria:

- 1) possess a doctoral degree (doctor of science)
- 2) high evaluation of the doctoral thesis or habilitation,
- 3) adequate scientific achievements covering, except the dissertation, also the other leading positions
- 4) active participation in academic life manifesting itself in particular in the speeches at conferences and symposia,
- 5) positive opinion from the manager or academic supervisor of the qualifications and abilities of the candidate to research and teaching, and in the case of candidates without a postdoctoral degree - information about the prospects habilitation

The ideal candidate should:

- 1) have experience in confocal fluorescence microscope
- 2) have familiarity with cellular and molecular biological analyses methods
- 3) have high motivation on analysing plant ER body function as a defense strategy
- 4) have international experience (scientific research outside of Poland for no less than 2 years)
- 5) have a good ability in scientific English
- 6) be a co-author of publications in journals from the ISIS Web of Science list (min 2 in last 3 years)

1. Motivation letter
2. CV
3. Personal questionnaire
4. A copy of a doctoral degree
5. A list of publications (including the publisher and page number)
6. Listed scientific activities
7. Opinion from a department directory or academic supervisor
8. A statement that Jagiellonian University will be the primary workplace in the case of being hired
9. A statement pursuant to art.10 item 1 of the Law of Higher Education
10. A statement of consent to assign the minimum amount of staff as needed
11. Establish the right to confer doctoral and postdoctoral and/or for the purpose of creating/running a higher education major if hired
12. A statement of knowledge and acceptance of the rules on intellectual property and legal protection of intellectual property

The deadline for submitting applications is 27th April 2016. The outcome of the contest will take place on 9th May 2016.
