- 1) Possess at magister/master degree in biotechnology, biochemistry, biophysics, molecular biology or any related field of life sciences
- 2) Have the qualification for being enrolled in a Polish PhD program
- 3) Have a strong expertise in molecular biology, protein biochemistry and structural biology, in particular in working with DNA gyrase proteins (essential) and familiarity with pentapeptide inhibitors of DNA gyrase.
- 4) Have excellent written and oral communication skills in English and Polish
- 5) Have good presentation skills
- 6) Show a good level of independence, self-motivation and reliability
- 7) Enjoy working in a highly collaborative and interdisciplinary environment
