Eligible contestants must meet the requirements in art. 109, which was established in 27.07.2005 followed by the Law on Higher Education (Dz. U. nr 164, poz. 1365, z późn. zm.) and meet the following qualification criteria:

The ideal candidate should:

- 1) Hold a doctoral degree/PhD in biotechnology, biochemistry, molecular cell biology or any related field of life sciences
- 2) Have a strong expertise in molecular biology, cell biology and structural biology
- 3) Have excellent written and oral communication skills in English (essential)
- 4) Have good presentation skills (ideally having presented on at least one international research conference)
- 5) enjoy working in a highly collaborative and interdisciplinary environment
- 6) enjoy scientifically supporting and actively interacting with other members of the lab
- 7) Have published at least one publications as first author in an international peer reviewed journal
