ASSISTANT PROFESSOR
in the research and teaching staff member group
at the Institute Astronomical Observatory
Faculty of Physics, Astronomy and Applied Computer Science
Academic field: ASTRONOMY

The competitive selection process is open for all individuals, who meet the requirements set out in Articles 113 and 116.2.3) of the Act of 20 July 2018 – Law on Higher Education and Science, and who meet the following eligibility criteria according to § 165 of the Statute of the Jagiellonian University:

- 1) Holding at least a doctoral degree;
- 2) Having relevant scientific achievements;
- 3) Taking active part in scientific life;
- 4) Having experience in teaching work.

Additional requirements for the candidate:

- 5) a high evaluation of the doctoral or habilitation thesis,
- 6) relevant scientific output, including, apart from the doctoral dissertation, also other important publications, active participation in scientific life, particularly in presentations at conferences and symposia,,
- 7) positive opinion of the direct superior (e.g. head of the department or scientific supervisor) on the candidate's qualifications and suitability for scientific and teaching work,
- 8) ability to conduct didactic classes for students in Polish and English.

We expect from the candidate:

- ability to conduct research within the research topics carried out in the Department of Radioastronomy and Space Physics, in particular observations and theoretical-modelling concerning the interstellar and intergalactic media of galaxies and radio galaxies,
- activity in obtaining financial resources for research,
- readiness to carry out research in foreign institutes when desirable.

- 1) application form,
- 2) resume,
- 3) personal questionnaire filled in by the candidate,
- 4) copy of the doctoral diploma or a diploma confirming the candidate's habilitation degree, if applicable,
- 5) summary of professional accomplishments reflecting the candidate's major research areas and scientific, teaching, and organisational achievements,
- 6) a list of publications (indicating the publisher and the number of pages),
- 7) information concerning educational activities carried out by the candidate, if any
- 8) doctoral dissertation or habilitation dissertation review, if applicable,
- 9) latest performance evaluation form, if the candidate was subject to such evaluation,

- 10) recommendation concerning the candidate's research and teaching work, issued by the director of the organisational unit or a scientific supervisor, including the results of student surveys and evaluations, if the candidate was subject to such evaluation,
- 11) declaration of the candidate, confirming that the Jagiellonian University will be their primary place of work, should they be selected in the competitive selection process,
- 12) declaration under Article 113 of the Law on Higher Education and Science,
- 13) declaration on acknowledging and accepting the rules and regulations concerning intellectual property management and commercialisation in force at the Jagiellonian University,
- 14) information regarding processing of personal data.

Application submission deadline: June 5, 2021.

The competitive selection process will be concluded by June 23, 2021.

Personal data processing information for job applicants

According to Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation – hereinafter GDPR), the Jagiellonian University informs that:

1. The Administrator of your personal data is the Jagiellonian University with its registered office in Gołębia 24, 31-007 Kraków, represented by the Rector of UJ.
2. The Jagiellonian University appointed the Data Protection Officer www.iod.uj.edu.pl, Gołębia 24, 30-007 Kraków. The Officer can be contacted by email: iod@uj.edu.pl or at the telephone number 12 663 12 25.
3. Your personal data will be processed in order to:
 - a. conduct recruitment process for the position specified in the advertisement on 29/04/2021- for post of an **ASSISTANT PROFESSOR** in the research and faculty staff member group in the Astronomical Observatory at the Faculty of Physics, Astronomy and Applied Computer Science – as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
 - b. conduct recruitment process for the position specified in the advertisement on 29/04/2021- for post of an **ASSISTANT PROFESSOR** in the research and faculty staff member group in the Astronomical Observatory at the Faculty of Physics, Astronomy and Applied Computer Science based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). Failure to provide you personal data will result in your inability to take part in the recruitment process. Submission of personal data processed on the basis of consent (Article 6 (1) lit a of the GDPR) is voluntary.
5. Your data will be processed during the recruitment period. In the event of not concluding the contract with you, your data will be deleted after the recruitment process.
6. You have the right of access to the content of your personal data, as well as the right to correct, delete, restrict processing, transfer, object to processing – on the terms and conditions set out in the GDPR.
7. If the processing is based on consent, you have the right to withdraw the consent at any time, which shall not affect the lawfulness of processing based on the consent given before the withdrawal. 8. Your personal data will not be subject to automated decision making or profiling.
9. You have the right to lodge a complaint with the Inspector General for the Protection of Personal Data, if you feel that the processing of your personal data violates the GDPR regulations.
