The competitive selection process is open for all individuals, who meet the requirements set out in Articles 113 and 116.2.3) of the Act of 20 July 2018 – Law on Higher Education and Science, and who meet the following eligibility criteria according to § 165 of the Statute of the Jagiellonian University:

- 1) Holding at least a doctoral degree
- 2) Having relevant scientific achievements
- 3) Taking active part in scientific life

# Additional criteria:

- 4) doctoral degree (within 7 years from receiving) in South Asian Studies/Indology or other field of Humanities or Social Studies with a pronounced focus on South Asia, preferably cultural history of India
- 5) proficient competence in at least one South Asian, preferably South Indian (Malayalam or/and Tamil) or early modern Hindi, Braj or Marathi, complemented by at least a working familiarity with Sanskrit
- 6) effective competence in close reading and cultural and historical analysis of early modern and colonial period texts from South Asia in original languages
- 7) a record of previous experience related to the research area of the project
- 8) proficient knowledge of English, sufficient to present project results and prepare academic publications
- 9) effective skills to conduct research in the project field and communicate its results in English
- 10) Sufficient skills and will to work in a team and share research results

The successful candidate shall be given full-time employment under a regular job contract for a duration of 10 months. The employed candidate shall report to the Project Coordinator, dr hab. Cezary Galewicz, prof. UJ.

# Job description:

The duties of the successful applicant shall comprise research tasks allotted by the Project Coordinator within the frame of the project indicated above, followed by documentation of research results to be published in internationally acclaimed journals, and shall include among else

- 1) independent research within the area of the project as indicated by the Project Coordinator
- 2) effective communication and active cooperation with the project team
- 3) presentation of the research results at conferences and workshops
- 4) active support in the editing process of the publications prepared within the frame of the project

- 7. Reccomendation letters of at least two independent scholars along with their contact details
- 8. declaration of the candidate, confirming that the Jagiellonian University will be their primary place of work, should they be selected in the competitive selection process
- 9. declaration under Article 113 of the Law on Higher Education and Science
- 10. declaration on acknowledging and accepting the rules and regulations concerning intellectual property management and commercialisation in force at the Jagiellonian University
- 11. information regarding processing of personal data

The competitive selection process shall take place in two stages:

- 2. Second stage in the form of on-line interview with shortlisted candidates

# Personal data processing information for job applicants

According to Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation – hereinafter GDPR), the Jagiellonian University informs that:

- 3. Your personal data will be processed in order to:
  - a. conduct recruitment process for the position specified in the advertisement as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
  - b. conduct recruitment process for the position specified in the advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
- 4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). Failure to provide you personal data will result in your inability to take part in the recruitment process. Submission of personal data processed on the basis of consent (Article 6 (1) lit a of the GDPR) is voluntary.
- 5. Your data will be processed during the recruitment period. In the event of not concluding the contract with you, your data will be deleted after the recruitment process.
- 6. You have the right of access to the content of your personal data, as well as the right to correct, delete, restrict processing, transfer, object to processing on the terms and conditions set out in the GDPR.
