announces a competitive selection process for the post of an ASSISTANT PROFESSOR
in the research staff member group
at the Copernicus Center for Interdisciplinary Studies of the Jagiellonian University

in academic discipline:
psychology or biological sciences, computer and information sciences or philosophy or linguistics
in the domain of mind and cognition research

**Duration of the contract: 30 months** 

The competitive selection process is open for all individuals who meet the requirements set out in Articles 113 and 116.2.3) of the Act of 20 July 2018 – Law on Higher Education and Science, and who meet the following eligibility criteria according to § 165 of the Statute of the Jagiellonian University:

- 1) Holding at least a doctoral degree;
- 2) Having relevant scientific achievements;
- 3) Taking active part in scientific life.

## Additionally:

The candidate should:

- -have relevant publication record at the international level in terms of papers in peer-reviewed journals and/or books; *Details*:
  - for papers in peer-reviewed journals, relevant publication record at the international level implies indexing of a given journal in one of the international databases: Scopus, Science Citation Index Expanded, Web of Science, etc. and having an impact factor; if the journal has been established recently and therefore does not meet the above-mentioned conditions, the selection board will evaluate its quality on the basis of its relation to an internationally recognized scientific society;
  - for a book monograph, a relevant publication record at the international level is understood here as the presence of a given publishing house at level 2 of the Polish ministerial list. If a monograph is written in a language other than Polish and published by a level 1 publishing house, the selection board will examine its quality individually (for example: a book published by Springer or Palgrave Macmillan is in principle an appropriate monograph with an international status):
  - publishing chapters in monographs or scientific editing of monographs and or editing special (thematic) issues of journals at the international level in the above sense will be an additional advantage;
- have experience in international academic cooperation (e.g., research stay during a doctorate, postdoctoral fellowship, cooperation with individual foreign scientists documented by publications or joint conference presentations, etc.);
- have experience in organizational and project work, in particular in managing or implementing research projects financed from external sources by way of a competition (e.g., National Science Centre of Poland, other state/national grant agencies, foundations supporting science, etc.);
- declare their readiness to conduct research on the mind and cognition; declared research should be conducted on the basis of the broadly understood components of the 4I principle: internationalization, interdisciplinarity, innovation, integrity;
- present a project of their research on the mind and cognition that they intend to implement during the period of employment;
- have good knowledge of at least one methodology used in widely understood research on the mind and cognition;
- have experience in interdisciplinary scientific work (understood, for example, as participation in interdisciplinary research teams);

#### We offer:

- full-time position of research assistant professor without teaching duties;
- a fixed-term employment contract for 30 months;
- access to research funds in the total amount of PLN 100 000 for 30 months; funds may be allocated to adapting the workplace, purchase of equipment (e.g., a computer), participation in conferences, short study trips, etc.

- 4. List of publications (underlining the three that the candidate considers the most important);
- 5. Personal data form for the person applying for employment \*;
- 6. Copy of the doctoral (Ph.D.) diploma or a diploma confirming the candidate's habilitation degree, if applicable;
- 7. Reviews of a doctoral dissertation or habilitation thesis if the candidate has one;
- 8. The last periodic evaluation form, if the candidate was subject to such evaluation;
- 9. Declaration of the candidate, confirming that the Jagiellonian University will be their primary place of work in the case of being selected in the competitive selection process \*;
- 10. Declaration under Article 113 of the Law on Higher Education and Science \*;
- 11. Declaration on acknowledging and accepting the rules and regulations concerning intellectual property management and commercialisation in force at the Jagiellonian University\*;
- 12. Information regarding processing of personal data \*;
- 13. A declaration of intention to conduct research on the mind and cognition along with a description of the research project. *Note*: The description of the research project should be prepared in English in the form of 5-10 pages of a standardized text: Times New Roman, font 12, line spacing 1.5; it should include a reference to the current state of research, hypotheses, methods, scope of the planned work with a schedule of tasks over time, as well as the assumed publication goals.

## Personal data processing information for job applicants

According to Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation – hereinafter GDPR), the Jagiellonian University informs that:

- 1. The Administrator of your personal data is the Jagiellonian University with its registered office in Gołębia 24, 31-007 Kraków, respresented by the Rector of UJ.
- 2. The Jagiellonian University appointed the Data Protection Officer www.iod.uj.edu.pl, Gołębia 24, 30-007 Kraków. The Officer can be contacted by email: iod@uj.edu.pl or at the telephone number 12 663 12 25.
- 3. Your personal data will be processed in order to:
  a. conduct recruitment process for the position specified in the specified advertisement as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
  - b. conduct recruitment process for the position specified in the specified advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
- 4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). Failure to provide you personal data will result in your inability to take part in the recruitment process. Submission of personal data processed on the basis of consent (Article 6 (1) lit a of the GDPR) is voluntary.
- 5. Your data will be processed during the recruitment period. In the event of not concluding the contract with you, your data will be deleted after the recruitment process.
- 6. You have the right of access to the content of your personal data, as well as the right to correct, delete, restrict processing, transfer, object to processing on the terms and conditions set out in the GDPR.
- 7. If the processing is based on consent, you have the right to withdraw the consent at any time, which shall not affect the lawfulness of processing based on the consent given before the withdrawal.
