THE RECTOR

of the Jagiellonian University announces a call for two positions of POSTDOCTORAL RESEARCHER

in a group of researchers at the Faculty of Geography and Geology in the field of socio-economic geography and spatial management in the scope of:

(1) spatial changes in the economic and social sphere and their determinants, creating new growth centers, the resilience of spatial systems to extreme events, the idea of sustainable development and consumption

and

(2) spatial changes in the economic, social and cultural spheres and the resilience of urban or rural systems to the challenges of the future, sustainable development of cities or rural areas

The call is open to persons who meet the conditions set out in Article 113, 116 s 2 item 3 of the Act of 20 July 2018 — the Law on Higher Education and Science and, pursuant to Article 165 of the Statute of the Jagiellonian University, meet the following qualification criteria:

- 1) hold at minimum a doctoral degree,
- 2) have relevant scientific achievements,
- 3) take an active part in scientific life.

The ideal candidate should meet the following criteria:

- 1. is a scientist with a doctoral degree in one of the academic disciplines cooperating with PRAs (Priority Research Areas) (https://futuresoc.id.uj.edu.pl/en_GB/about-us),
- 2. has experience in international academic cooperation with leading research centers,
- 3. has scientific achievements in the form of publications in renowned journals or at renowned conferences related to the subject of the call (in particular, holds the main authorship of publications in journals included in one of the international databases: Scopus, Science Citation Index Expanded, Social Sciences Citation Index, Arts & Humanities Citation Index, is the author of a reviewed scientific monograph from the 2nd / 1st level list of the Polish list of publishers (https://listymnisw.pl/full.php), or publications in reviewed materials from an international conference indexed in the Web of Science Core Collection or Scopus databases),
- 4. has experience in organizational and design work in particular in the implementation of projects financed from external sources obtained through a competition (e.g., is / has been a project manager, main contractor, or co-contractor of at least one completed research grant obtained from external sources),
- 5. undertakes cooperation with other members of the research group,
- 6. has experience in popularizing science and innovative education,
- 7. has experience in cooperation within the socio-economic environment,
- 8. is fluent in spoken and written English.

Expectations:

- 1. publishing in high-scoring journals (at least two publications in journals indexed in international journal databases, including interdisciplinary team publications, published or accepted for publication) and on the list of the Ministry of Education and Science (https://listymnisw.pl/full.php),
- 2. implementation of a complex research plan, in cooperation with employees of the Faculties as part of FutureSoc PRA.
- 3. submission, within 24 months of starting employment at the Jagiellonian University, at least one application for an external international grant affiliated with the Jagiellonian University and awarded through a competition,
- 4. engaging the academic community in research, cooperation with the Glocal Challenges Lab and FutureSoc PRA in the field of scientific research, promotion of science, cooperation with the social and economic environment of the University,

5. representing the university externally (through popularizing research results).

We offer:

- 1. The offered remuneration includes base salary and an allowance.
- 2. A fixed-term employment contract of 30 months.
- 3. The candidate will receive a research grant under the Glocal Challenges Lab (in the amount of PLN 100,000 for a period of up to 30 months). Under the fund, eligible costs may include, in particular, travel for the purpose of research and participation in conferences and workshops, and preparation of publications.

In addition, the candidate will receive funding for a research grant for up to 30 months, financed by the Glocal Challenges Lab, under which the candidate will implement a project that fits the research topic of the Glocal Challenges Lab (https://futuresoc.id.uj.edu.pl/en_GB/gcl). The topics should concern challenges of the future related to the economy, demographic issues, spatial changes in various spheres, issues related to leisure or cultural challenges (the first position) or challenges of the future related to changes in cities or rural areas (the second position).

The proposed research should comply with the 4I principle and be interdisciplinary, innovative, contribute to internationalization and integration with the external environment.

- 1. application for employment,
- 2. a resume containing, in particular, a list of publications, list of awards and distinctions obtained, list of internships and residences in research units, list of completed and ongoing research projects (as a manager or contractor) with an indication of the sources of funding thereof,
- 3. a copy of the doctoral or habilitation diploma, if applicable,
- 4. information on the candidate's research, teaching, and organizational achievements,
- 5. reviews of a doctoral dissertation or habilitation thesis, if applicable,
- 6. two recommendation letters from two scientists with whom the candidate has cooperated previously,
- 7. a copy of the candidate's selected publication in English,
- 8. a document confirming the candidate's fluency in English (with the exception of people for whom English is the mother tongue or if the language of instruction during academic education was English please provide a copy of the diploma with the language of instruction indicated).
- 9. initial description of the research project aligned with the areas of interest of the Glocal Challenges Lab (a project description of up to 5,000 characters without spaces in English). The project should clearly indicate the following: the relationship with the research topic indicated in the call (as described above), the project objectives, the research methodology and work schedule, the planned project results, the forms of dissemination of results (including cooperation within the socio-economic environment), the project's importance for the areas of interest of the Glocal Challenges Lab and FutureSoc PRA (https://futuresoc.id.uj.edu.pl/en_GB/about-us) and the rationale for applying the 4I principle, as well as a bibliography.
- 10. a completed personal information form concerning the applicant,
- 11. a declaration that the Jagiellonian University will be the primary place of work in the event of the candidate being employed,
- 12. a representation pursuant to Article 113 of the Law on Higher Education and Science,
- 13. a declaration of the knowledge and acceptance of the principles of intellectual property management and the principles of commercialization of the Jagiellonian University,
- 14. information on the processing of personal data,

Personal data processing information for job applicants

According to Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation – hereinafter GDPR), the Jagiellonian University informs that:

- 3. Your personal data will be processed in order to:
 - a. conduct recruitment process for the position specified in the specified advertisement as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
 - b. conduct recruitment process for the position specified in the specified advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
- 4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). Failure to provide you personal data will result in your inability to take part in the recruitment process. Submission of personal data processed on the basis of consent (Article 6 (1) lit a of the GDPR) is voluntary.
- 5. Your data will be processed during the recruitment period. In the event of not concluding the contract with you, your data will be deleted after the recruitment process.
- 6. You have the right of access to the content of your personal data, as well as the right to correct, delete, restrict processing, transfer, object to processing on the terms and conditions set out in the GDPR.
- 7. If the processing is based on consent, you have the right to withdraw the consent at any time, which shall not affect the lawfulness of processing based on the consent given before the withdrawal.
