announces a competitive selection process for the post

of a UNIVERSITY PROFESSOR

in the group of research employees

of the Faculty of Management and Social Communication

in the field of social aspects of the digital environment, including in particularly the research of modern tools and information and communication systems, and of digital systems and media messages within the social sciences in research field of social communication and the media studies and related fields

The competitive selection process is open for all individuals, who meet the requirements set out in Articles 113 and 116.2.2) of the Act of 20 July 2018 – Law on Higher Education and Science, and who meet the following eligibility criteria according to § 163 of the Statute of the Jagiellonian University:

- 1) holding at least a doctoral degree,
- 2) having significant and creative achievements in scientific, professional or artistic work,
- 3) having achievements in organizational work.

#### Additionally:

- 4) candidates have significant and creative achievements in scientific, professional or artistic work in the form of, among others: publications in reputable journals or at renowned conferences devoted to the social aspects of researching the digital environment, including in particular research of modern tools and information and communication systems and digital systems and media messages conducted within the research field of social communication and the media studies and related fields (see, for instance, Scopus research fields, such as: Communication, Library and Information Sciences, Information Systems, Human-Computer Interaction, Computer Networks and Communications and others)
- 5) a person entering the competition must not be employed under an employment contract at the Jagiellonian University within two years from the date of the competition.

The ideal candidate should meet the following criteria:

- 1) take an active part in scientific life, manifested in particular in speeches at international conferences and symposia;
- 2) have experience in interdisciplinary scientific work or in cooperation with the socio-economic environment,
- 3) have experience in organizational and design work, in particular in the implementation of research projects financed from external sources by way of a competition and in obtaining funds for research from such sources,
- 4) participate in international academic cooperation with leading research centers,
- 5) have experience in popularizing science or innovative education,
- 6) have a good command of the spoken and written English language.

Expectations (assessed after 24 months of employment):

1) publishing articles in reputable journals with high IF, for which the Jagiellonian University is the only Polish affiliation,

- 2) submission of at least one application for an external Polish or international grant, affiliated to the Jagiellonian University,
- 3) engaging scientists from the academic community of the Jagiellonian University in interdisciplinary research.

### **University offers:**

- 1) remuneration in the maximum amount of 150,000-200,000 PLN gross annually for the duration of the research grant conducted on the basis of a separate agreement (the remuneration includes the base remuneration with an increase related to the implementation of the research grant and any additional remuneration components in accordance with the Remuneration Regulations for employees of the Jagiellonian University),
- 2) based on the cost estimate and research plan, it is planned to award a research grant and an amount of approx. 400,000 PLN subject to and under the conditions specified in a separate agreement (the possibility of financing, among others, research equipment, perishable materials, services, business trips, involvement of students and doctoral students)
- 3) under the above-mentioned a research grant, the possibility of financing, in addition to the above-mentioned amount, the involvement of two postdocs subject to and under the conditions specified in a separate agreement,

- 1. letter of intent or interest,
- 2. preliminary research proposal to be carried out during the employment at JU, which should fall within the scope of the "Digital transformation of society and economy" research domain of priority research area *DigiWorld* (see <a href="https://id.uj.edu.pl/digiworld">https://id.uj.edu.pl/digiworld</a> "Priority Research Area description"),
- 3. resume which should contain: a list of publications, a list of awards and distinctions obtained, a list of internships and stays in research institutions, a list of completed and ongoing research projects (as a PI or contractor) with an indication of funding sources,
- 4. essay presenting the candidate's most important achievements and research plans,
- 5. personal questionnaire filled in by the candidate,
- 6. copy of the doctoral diploma or a diploma confirming the candidate's habilitation degree, if applicable,
- 7. information on the candidate's scientific and organisational achievements,
- 8. doctoral dissertation or habilitation dissertation review, if applicable,
- 9. declaration of the candidate, confirming that the Jagiellonian University will be their primary place of work, in case of winning the selection process,
- 10. declaration under Article 113 of the Law on Higher Education and Science,
- 11. declaration on acknowledging and accepting the rules and regulations concerning intellectual property management and commercialisation in force at the Jagiellonian University;
- 12. information regarding processing of personal data.

Shortlisted candidates will be invited for an online interview.

The competitive selection process will be concluded by: 31st January 2022

Planning date of commencement of work: 1st March 2022.

## Personal data processing information for job applicants

According to Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation – hereinafter GDPR), the Jagiellonian University informs that:

- 3. Your personal data will be processed in order to:
  - a. conduct recruitment process for the position specified in the advertisement no. 817.1101.12.2021 as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
  - b. conduct recruitment process for the position specified in the advertisement no. 817.1101.12.2021 based on your consent pursuant to Art. 6 (1) lit a of the GDPR your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
- 4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). Failure to provide you personal data will result in your inability to take part in the recruitment process. Submission of personal data processed on the basis of consent (Article 6 (1) lit a of the GDPR) is voluntary.
- 5. Your data will be processed during the recruitment period. In the event of not concluding the contract with you, your data will be deleted after the recruitment process.
- 6. You have the right of access to the content of your personal data, as well as the right to correct, delete, restrict processing, transfer, object to processing on the terms and conditions set out in the GDPR.
- 7. If the processing is based on consent, you have the right to withdraw the consent at any time, which shall not affect the lawfulness of processing based on the consent given before the withdrawal.
