**(principal investigator: Marek Rams, PhD)**

The competitive selection process is open for all individuals, who meet the requirements set out in Articles 113 and 116.2.4) of the Act of 20 July 2018 – Law on Higher Education and Science, and who meet the following eligibility criteria according to § 166 of the Statute of the Jagiellonian University:

- 1) Holding at least a Master’s degree, Master of Science degree or an equivalent degree;
- 2) Exhibiting aptitude for research work;

Additional requirements:

- 1) High level of academic competence in theoretical investigation of quantum many-body systems, quantum transport calculations or tensor networks confirmed by solid publication record.
- 2) Good knowledge of English and the willingness to work in a team.
- 3) Creativity, independence and self-discipline.

Project description: The project focuses on develop of novel numerical renormalization techniques for nonequilibrium states in many-body quantum transport, following recognition that this broad class of problems possesses an information-theoretic structures that allow for efficient simulations.

Key responsibilities:

- 1) Active scientific research
- 2) Presentation of results at scientific conferences, publication of results in peer-reviewed journals. Participation in seminars, group meetings, and other activities of scientific exchange. Close collaboration with other group members.
- 3) Participation in mentoring of PhD students.

We offer:

- 1) full-time employment for up to 36 months. Gross salary 10000PLN per month (brutto-brutto, maximal NCN postdoc salary), equivalent to about 6000PLN netto plus social and health insurance.
  - 2) Employment from April 1st, 2022 (starting date can be postponed up to few months)
  - 3) Broad international collaborations;

## Personal data processing information for job applicants

3. Your personal data will be processed in order to:
  - a. conduct recruitment process for the position specified in the advertisement for a position of a research assistant in the research staff group at the Institute of Theoretical Physics of the Faculty of Physics, Astronomy and Applied Computer Science academic field physics in the project of National Science Center, Poland, Sonata Bis 10 „*Quantum tensor networks: from spin glasses to quantum transport*” – as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
  - b. conduct recruitment process for the position specified in the advertisement for a position of a research assistant in the research staff group at the Institute of Theoretical Physics of the Faculty of Physics, Astronomy and Applied Computer Science academic field physics in the project of National Science Center, Poland, Sonata Bis 10 „*Quantum tensor networks: from spin glasses to quantum transport*” based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator. 7. If the processing is based on consent, you have the right to withdraw the consent at any time, which shall not affect the lawfulness of processing based on the consent given before the withdrawal.
