The competitive selection process is open for all individuals, who meet the requirements set out in Articles 113 and 116.2.4) of the Act of 20 July 2018 – Law on Higher Education and Science, and who meet the following eligibility criteria according to § 166 of the Statute of the Jagiellonian University:

- 1) Holding at least a Master's degree, Master of Science degree or an equivalent degree;
- 2) Exhibiting aptitude for research work;

**Specific required qualifications:**

- 3) Scientific achievements documented by publications in international journals, in particular knowledge of research techniques listed below - documented by publications;
- 4) Fluency in cell culture methods;
- 5) The use of genetic engineering techniques for the construction of plasmid and viral vectors;
- 6) Experience in the application of CRISPR / Cas9 gene editing technique;
- 7) Experience in obtaining and characterizing induced pluripotent stem cells (iPSC);
- 8) Experience in iPSC differentiation;
- 9) Experience in animal research;
- 10) Knowledge of flow cytometry techniques;
- 11) Knowledge of immunocytochemical and immunofluorescence techniques;
- 12) Experience in other techniques of molecular biology;
- 13) Knowledge of basic methods of analysis of transcriptome data.

Additional requirements due to employment in the frame of the NCN-funded Sheng project: post-doc position. **The candidate must meet all requirements indicated for post-doc position in Annex 2 to NCN Council Resolution No 136/2020 of 11 December 2020**

6. latest performance evaluation form, if the candidate was subject to such evaluation;
7. recommendation concerning the candidate's ability to work as an academic teacher, issued by the director of the organisational unit or a scientific supervisor, including the results of student surveys and evaluations, if the candidate was subject to such evaluation, as well as recommendation concerning the candidate's scientific work;
8. declaration of the candidate, confirming that the Jagiellonian University will be their primary place of work, should they be selected in the competitive selection process;
9. declaration under Article 113 of the Law on Higher Education and Science;
10. declaration on acknowledging and accepting the rules and regulations concerning intellectual property management and commercialisation in force at the Jagiellonian University;
11. information regarding processing of personal data.

### Personal data processing information for job applicants

According to Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation – hereinafter GDPR), the Jagiellonian University informs that:

3. Your personal data will be processed in order to:
  - a. conduct recruitment process for the position specified in the advertisement– as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
  - b. conduct recruitment process for the position specified in the advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). Failure to provide you personal data will result in your inability to take part in the recruitment process. Submission of personal data processed on the basis of consent (Article 6 (1) lit a of the GDPR) is voluntary.
5. Your data will be processed during the recruitment period. In the event of not concluding the contract with you, your data will be deleted after the recruitment process.
6. You have the right of access to the content of your personal data, as well as the right to correct, delete, restrict processing, transfer, object to processing – on the terms and conditions set out in the GDPR.
7. If the processing is based on consent, you have the right to withdraw the consent at any time, which shall not affect the lawfulness of processing based on the consent given before the withdrawal.
