of the Jagiellonian University announces a competitive selection process for the post of an ASSISTANT in the research staff (post-doc)

in the Protein Crystallography Research Group at MCB

as part of the project implementation
"Structural insight into the peroxisomal protein import – the PEX translocon"
financed by the National Science Centre as part of the Opus 20 programme
academic field of biochemistry and structural biology

The competitive selection process is open for all individuals, who meet the requirements set out in Articles 113 and 116.2.4) of the Act of 20 July 2018 – Law on Higher Education and Science, and who meet the following eligibility criteria according to § 166 of the Statute of the Jagiellonian University:

- 1) Holding at least a Master's degree, Master of Science degree or an equivalent degree;
- 2) Exhibiting aptitude for research work;
- 3) Active participation in academic life involving particularly presentations at conferences and symposiums,
- 4) Working experience in renowned international research institution,
- 5) Has at least one original first-authorship publications in scientific journals.

The candidate is expected to have prior knowledge and experience in:

- 1. Obtaining proteins in bacterial systems,
- 2. Purification of proteins using chromatographic methods,
- 3. Protein crystalization,
- 4. X-ray diffraction experiments and data interpretation (solving of X-ray structures)
- 5. Knowledge of other methods of structural biology (cryo-EM, cryo-ET, NMR, SAXS, FRET, etc.) or biological imaging (TEM, confocal, Raman, etc.) will be of additional advantage,
- 6. Preparation of reports, presentations, and scientific papers,
- 7. Has a fluent knowledge of English.

As part of the daily work it is expected to coordinate the daily organization of different components of the project, to orient and include students in the experiments and to perform strong working ethic.

Candidates who apply for the post are required to file in the Director's Office of the Malopolska Centre of Biotechnology of the Jagiellonian University; Kraków, ul. - 5. information on the candidate's scientific, teaching and organisational achievements;
- 6. list of publications (along with the respective publishing houses and the number of pages), if applicable;
- 7. information concerning educational activities carried out by the candidate, if any
  - this requirement does not apply to candidates for positions in the research staff member group.
- 8. latest performance evaluation form, if the candidate was subject to such evaluation;

- 9. recommendation concerning the candidate's ability to work as an academic teacher, issued by the director of the organisational unit or a scientific supervisor, including the results of student surveys and evaluations, if the candidate was subject to such evaluation, as well as recommendation concerning the candidate's scientific work;
- 10. declaration of the candidate, confirming that the Jagiellonian University will be their primary place of work, should they be selected in the competitive selection process;
- 11. declaration under Article 113 of the Law on Higher Education and Science;
- 12. declaration on acknowledging and accepting the rules and regulations concerning intellectual property management and commercialisation in force at the Jagiellonian University;
- 13. information regarding processing of personal data;

## Personal data processing information for job applicants

According to Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation – hereinafter GDPR), the Jagiellonian University informs that:

- 1. The Administrator of your personal data is the Jagiellonian University with its registered office in Gołębia 24, 31-007 Kraków, respresented by the Rector of UJ.
- 2. The Jagiellonian University appointed the Data Protection Officer www.iod.uj.edu.pl, Gołębia 24, 30-007 Kraków. The Officer can be contacted by email: iod@uj.edu.pl or at the telephone number 12 663 12 25.
- 3. Your personal data will be processed in order to:
  - a. conduct recruitment process for the position specified in the advertisement of 03.01.2022 as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
  - b. conduct recruitment process for the position specified in the advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
- 4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). Failure to provide you personal data will result in your inability to take part in the recruitment process. Submission of personal data processed on the basis of consent (Article 6 (1) lit a of the GDPR) is voluntary.
- 5. Your data will be processed during the recruitment period. In the event of not concluding the contract with you, your data will be deleted after the recruitment process.
- 6. You have the right of access to the content of your personal data, as well as the right to correct, delete, restrict processing, transfer, object to processing on the terms and conditions set out in the GDPR.
- 7. If the processing is based on consent, you have the right to withdraw the consent at any time, which shall not affect the lawfulness of processing based on the consent given before the withdrawal.
