The competitive selection process is open for all individuals, who meet the requirements set out in Articles 113 and 116.2.3) of the Act of 20 July 2018 – Law on Higher Education and Science, and who meet the following eligibility criteria according to § 165 of the Statute of the Jagiellonian University:

- 1) Holding at least a doctoral degree;
- 2) Having relevant scientific achievements;
- 3) Taking active part in scientific life.

### **Perfect candidate should have:**

- knowledge of basic biochemical techniques, including western blot, SDS-PAGE, ELISA, enzymatic assays;
- experience in protein purification;
- experience in enzyme activity characterization (activity assays, enzyme activation/inhibition analysis, binding constants) AND/OR protein structure-function analysis using biophysical techniques (SPR, MST, tryptophan fluorescence);
- good knowledge of analytical software and techniques;
- knowledge of standard office and figure-preparation applications (MS Office, Adobe Photoshop and Illustrator or similar equivalents);
- fluent in written and spoken English;
- experience in the conference presentation (oral/poster);
- international experience.

- 5) information on the candidate’s scientific, teaching and organisational achievements;
- 6) list of publications (along with the respective publishing houses and the number of pages);
- 7) doctoral dissertation or habilitation dissertation review, if applicable;
- 8) latest performance evaluation form, if the candidate was subject to such evaluation;
- 9) recommendation concerning the candidate’s research and teaching work, issued by the director of the organisational unit or a scientific supervisor, including the results of student surveys and evaluations, if the candidate was subject to such evaluation;

- 10) declaration of the candidate, confirming that the Jagiellonian University will be their primary place of work, should they be selected in the competitive selection process;
- 11) declaration under Article 113 of the Law on Higher Education and Science;
- 12) declaration on acknowledging and accepting the rules and regulations concerning intellectual property management and commercialisation in force at the Jagiellonian University;
- 13) information regarding processing of personal data.

### Personal data processing information for job applicants

3. Your personal data will be processed in order to:
  - a. conduct recruitment process for the position specified in the advertisement from 03/02/2022 for the post of an ASSISTANT PROFESSOR in the research staff member group in the Malopolska Centre of Biotechnology – as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
  - b. conduct recruitment process for the position specified in the advertisement from 03/02/2022 for the post of an ASSISTANT PROFESSOR in the research staff member group in the Malopolska Centre of Biotechnology based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). 5. Your data will be processed during the recruitment period. In the event of not concluding the contract with you, your data will be deleted after the recruitment process.
6. You have the right of access to the content of your personal data, as well as the right to correct, delete, restrict processing, transfer, object to processing – on the terms and conditions set out in the GDPR.
