- 1) Holding at least a doctoral degree;
- 2) Having relevant scientific achievements;
- 3) Taking active part in scientific life;

In addition following criteria will be taken into account:

- 1) A fluent command of English and Polish;
- 2) Basic competences in an analysis of media contents and media policies in an international environment;
- 3) Good communication, co-operation and organisational skills, ability to work in an international team;
- 4) Analytical skills

## Information on Personal Data Processing for a candidate

Pursuant to Article 13 of the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter: GDPR), the Jagiellonian University informs that:

1. The Controller of your personal data is the Jagiellonian University, with a registered seat at ul. Gołębia 24, 31-007 Kraków, represented by the JU Rector.

3. Your personal data will be made available for the purposes of:
  - a) conducting the procedure of recruitment for the position of assistant professor in the research staff at the Institute of Journalism, Media and Social Communication in compliance with the legal obligation to which the Controller is subject pursuant to Article 6.1(c) of the GDPR, in connection to the Act: Labour Code;
  - b) conducting the procedure of recruitment for the position of assistant professor in the research staff at the Institute of Journalism, Media and Social Communication pursuant to the expression of consent pursuant to Article 6.1(a) of the GDPR: your consent is your express action in the form of sending your CV to the Controller. The consent to have your personal data processed pertains to the data you voluntarily provide in the submitted CV, which do not stem from the provisions of the Act: the Labour Code.
4. The obligation for you to provide your personal data stems from the provisions of law (applies to the personal data processed pursuant to Article 6.1(c) of the GDPR). Failure to provide personal data precludes participation in the recruitment procedure. Providing the personal data processed pursuant to the consent (Article 6.1(a) of the GDPR) is voluntary.
5. Your data shall be processed over the course of the recruitment process. In the event that a contract is not concluded with you, your data will be deleted once the recruitment process has ended.
6. You have the right to: access the data and demand their rectification, deletion, processing restrictions, transfer the data, object to the processing of data on terms stipulated in the GDPR.
7. If the processing is conducted by consent, you have the right to withdraw your consent at any time with no consequences for the compliance with the right to processing of the processing done by consent before the withdrawal. 9. You have the right to lodge a complaint with the President of the Office for Personal Data Protection, should you ascertain that the processing of your personal data violates the provisions of the GDPR.
