The call is open for all individuals, who meet the requirements set out in Articles 113 and 116.2.3 of the Act of 20 July 1918 – Law on Higher Education and Science, and who meet the following eligibility criteria according to § 165 of the Statute of the Jagiellonian University:

- Holding a doctoral degree
- Having relevant academic achievements
- Taking active part in scientific life

**Additional expectations:**

- English language proficiency is required
- Experience with international collaborative research projects would be an advantage.

**JOB DESCRIPTION:** The Taube Centre for Advanced Studies in the Social Sciences Jagiellonian University in Kraków invites applications for an Assistant Professor (Postdoc) position interested carrying out research on the general subject of **“New challenges to democracy”**.

In particular the following areas of research are suggested:

- politics of history/history of politics and the crisis of democracy; illiberal democracy/post-democracy. Is ‘illiberal democracy’ an oxymoron or a legitimate alternative to the liberal tradition? The future of the EU’s democratic spirit
- digital citizenship
- migration questions: security and the future of integration of the democratic EU; migration from the perspective of critical race theory and feminist theories
- representation in democracy (immigrants, minorities, women); representation of democracy
- democracy in the post-Covid era; security; liberal values; populist denial of science and expertise
- security and the climate change

Candidates are expected to propose topics of research they would like to carry out during the year of employment at the Taube Centre.

Length of contract and % of full-time: The position is full time and announced for a period of 1 year (September 2022 – August 2023) without teaching obligations.

Candidates applying for the posts should submit the following documents:

1. **A concise research proposal in English. The proposal should be about 8,000 characters incl. spaces and should include: the academic problem(s) addressed; a critical consideration of relevant literature; the research goals and expected results; work and time schedule**
2. **Resume**
3. **Copy of doctoral diploma or diploma confirming that the candidates's habilitaion degree, if applicable**
4. **Doctoral dissertation or habilitation dissertation review, if applicable**
5. **Latest performance evaluation form, if the candidate was subject to such evaluation**
6. **List of publications (along with the respective publishing houses and the number of pages)**
7. **Two letters of recommendation by scholars familiar with the applicant's academic work.**
8. **Personal questionnaire filled in by the candidate (see the forms under the link given below)**
9. Information regarding the processing of personal data (see below)

## Personal data processing information for job applicants

According to Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation – hereinafter GDPR), the Jagiellonian University informs that:

3. Your personal data will be processed in order to:
  - a. conduct recruitment process for the position specified in the advertisement specified in this job advertisement – as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
  - b. conduct recruitment process for the position specified in this job advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). Failure to provide your personal data will result in your inability to take part in the recruitment process. Submission of personal data processed on the basis of consent (Article 6 (1) lit a of the GDPR) is voluntary.
5. Your data will be processed during the recruitment period. In the event of not concluding the contract with you, your data will be deleted after the recruitment process.
6. You have the right of access to the content of your personal data, as well as the right to correct, delete, restrict processing, transfer, object to processing – on the terms and conditions set out in the GDPR.
7. If the processing is based on consent, you have the right to withdraw the consent at any time, which shall not affect the lawfulness of processing based on the consent given before the withdrawal.
