academic field biological sciences to implement the OPUS 19 grant:

"Is mitonuclear co-adaptation a driver of amphibian speciation?" (K/PBO/000793) funded by the National Science Centre of Poland

The competitive selection process is open for all individuals who meet the requirements set out in Articles 113 and 116.2.3) of the Act of 20 July 2018 – Law on Higher Education and Science, and who meet the following eligibility criteria according to § 165 of the Statute of the Jagiellonian University:

- 1) Holding at least a doctoral degree;
- 2) Having relevant scientific achievements;
- 3) Taking active part in scientific life.

Additional eligibility criteria:

- 1) Having scientific achievements, including publications in zoology and/or evolutionary biology in scientific journals from the JCR list;
- 2) the applicant should have practical training in:
 - a. a molecular genetics lab (inclding DNA extraction, PCR),
 - b. DNA sequence analysis and/or basic bioniformatics skills (in BASH, PYTHON, R or similar language);
- 3) proficiency in English;
- 4) availability for intensive labwork between June-August involving amphibian husbandry and measurements of live tadpoles in an experimental setting
- 5) willingness to gain new skills and achievements in the field of speciation genetics
- 6) good organizational skills and the ability to work independently in a molecular lab.

The candidate must also meet all criteria for the post-doc position required by National Science Centre of Poland (OPUS grant) on the day of commencement of employment.

- 2. resume;
- 3. personal questionnaire filled in by the candidate;
- 4. copy of the doctoral diploma or a diploma confirming the candidate's habilitation degree, if applicable;
- 5. information on the candidate's scientific, teaching and organisational achievements;
- 6. list of publications (along with the respective publishing houses and the number of pages);
- 7. doctoral dissertation or habilitation dissertation review, if applicable;
- 8. latest performance evaluation form, if the candidate was subject to such evaluation;
- 9. recommendation concerning the candidate's research and teaching work, issued by the director of the organisational unit or a scientific supervisor,
- 10. declaration of the candidate, confirming that the Jagiellonian University will be their primary place of work, should they be selected in the competitive selection process;
- 11. declaration under Article 113 of the Law on Higher Education and Science;
- 12. declaration on acknowledging and accepting the rules and regulations concerning intellectual property management and commercialisation in force at the Jagiellonian University;
- 13. information regarding processing of personal data;

Personal data processing information for job applicants

- 3. Your personal data will be processed in order to:
 - a. conduct recruitment process for the position specified in the advertisement for the post of an ASSISTANT PROFESSOR in the research staff of the Faculty of Biology to implement the OPUS 19 grant: "Is mitonuclear co-adaptation a driver of amphibian speciation?" (K/PBO/000793) funded by the National Science Centre of Poland as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
 - b. conduct recruitment process for the position specified in the advertisement for the post of an ASSISTANT PROFESSOR in the research staff of the Faculty of Biology to implement the OPUS 19 grant: "Is mitonuclear co-adaptation a driver of amphibian speciation?" (K/PBO/000793) funded by the National Science Centre of Poland, based on your consent pursuant to Art. 6 (1) lit a of the GDPR your consent is granted by the clear action of submitting your CV with the Administrator. Submission of personal data processed on the basis of consent (Article 6 (1) lit a of the GDPR) is voluntary.
- 5. Your data will be processed during the recruitment period. In the event of not concluding the contract with you, your data will be deleted after the recruitment process.
- 6. You have the right of access to the content of your personal data, as well as the right to correct, delete, restrict processing, transfer, object to processing on the terms and conditions set out in the GDPR.
- 7. If the processing is based on consent, you have the right to withdraw the consent at any time, which shall not affect the lawfulness of processing based on the consent given before the withdrawal.
