<b>Project description</b>	<p>We are looking for an Assistant Professor (Postdoc) in the research group of Molecular Mechanisms of Symbiosis at the Institute of Environmental Sciences of the Jagiellonian University. The employed person will join a newly created team whose goal will be to discover the molecular mechanisms of interaction between the intracellular Wolbachia bacteria and insects. The project will be carried out using molecular biology techniques, next-generation sequencing (NGS) and confocal microscopy.</p> <p>This position will be funded by the European Research Council.</p>

3. Your personal data will be processed in order to:
  - a. conduct recruitment process for the position specified in the advertisement as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
  - b. conduct recruitment process for the position specified in the advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). Failure to provide you personal data will result in your inability to take part in the recruitment process.
