### Project Title

Uncovering the mechanisms of action of an antiviral bacterium

### **Project description**

We are looking for an Assistant Professor (Postdoc) in the research group of Molecular Mechanisms of Symbiosis at the Institute of Environmental Sciences of the Jagiellonian University. The employed person will join a newly created team whose goal will be to discover the molecular mechanisms of interaction between the intracellular Wolbachia bacteria and insects. The project will be carried out using molecular biology techniques, next-generation sequencing (NGS) and confocal microscopy.

This position will be founded by the European Research Council.
