Project description	<p>The Flagship Project 'Critical Heritage Studies Hub' is conceived as a platform to coordinate research, education, and public engagement in critical reflection on heritage. Particular attention will be paid to so-called difficult or dissonant heritage. The Hub:</p> <ol style="list-style-type: none"> 1/ supports interdisciplinary research through: <ul style="list-style-type: none"> – exchange of ideas, – development of mechanisms to facilitate the formation of sustainable international research teams, and – development of digital tools to support heritage research; 2/ collaborates with the socio-economic environment by: <ul style="list-style-type: none"> – organising public debates, – disseminating knowledge and engaging in educational activities, which includes preparing reports and analyses, – cooperation with cultural institutions, NGOs, JST, and the business sector, especially within the Think Tank as part of the HUB, 3/ engages in intensive international cooperation in research, teaching, and community engagement projects, including within the Una Europa alliance. <p>The Hub is based on two pillars that correspond to two specific objectives: A think tank for critical discourse on heritage, and research groups.</p> <p>The recruitment of a full-time assistant is intended to strengthen the think tank activities. In particular, the postholder will be involved in the implementation of educational activities, including the organisation of seminars, conferences and events, the development of Massive Open Online Courses, summer schools, and podcasts in collaboration with the University's socio-economic environment.</p>

The Candidate has the right to appeal against the negative assessment by the selection board within 7 days from receiving the information about the results of the assessment.

3. Your personal data will be processed in order to:
 - a. conduct recruitment process for the position specified in the above advertisement – as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
 - b. conduct recruitment process for the position specified in the above advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). Failure to provide you personal data will result in your inability to take part in the recruitment process.
