- 3. Your personal data will be processed in order to:
  - a) conduct recruitment process for the position specified in the advertisement from 12.05.2023 for the post of an ASSISTANT PROFESSOR in the research staff member group in the Malopolska Centre of Biotechnology – as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
  - b) conduct recruitment process for the position specified in the advertisement from 12.05.2023 for the post of an ASSISTANT PROFESSOR in the research staff member group in the Malopolska Centre of Biotechnology based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator.
