Program / Project description	The Symbiosis Evolution Group at the Institute of Environmental Sciences at the Faculty of Biology of the Jagiellonian University is looking for candidates for a 10-month full-time position. The Assistant Professor will be employed within the Polish National Science Centre (NCN) project aiming to understand the factors and processes shaping the diversity of Arctic insects and their relationships with symbiotic microorganisms. The Assistant Professor will be responsible for fieldwork, sample processing in the laboratory, and bioinformatics analyzes of NGS data: analysis of amplicon data, genome assembly and characterization, comparative analysis of symbiont genomes, and phylogenomic analyses. They will also prepare publications and present the results at international conferences.

Personal data processing information for job applicants

- Your personal data will be processed in order to:

 a. conduct recruitment process for the position specified in the above advertisement as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;

b. conduct recruitment process for the position specified in the above advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.

- 4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR).
