- 3. Your personal data will be processed in order to:a. conduct recruitment process for the position specified in the above advertis
 - a. conduct recruitment process for the position specified in the above advertisement as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
 - b. conduct recruitment process for the position specified in the above advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR your consent is granted by the clear action of submitting your CV with the Administrator.
