<b>Job role</b>	<p>We are looking for an exceptional scientist to conduct research in RNA cellular signalling. Malopolska Centre of Biotechnology (MCB) is an international postgraduate research institute within the Jagiellonian University with English as the operating language. We work on the gene to protein to function to translation continuum in three key areas of research. Host-microorganism-environment, macromolecular interactions and cell-signalling, We have a number of research groups across these fields who study RNA protein interactions and structures of these complexes, RNA viruses and various nodal signalling cascades that interact between RNA, RNA binding proteins and diseases such as diabetes. We are looking for a highly accomplished individual for a short term contract valid until 31 March 2025 to bring in RNA cellular signalling know-how including transcriptome analysis to complement our existing groups. Since several of our groups are working on translation to neurodevelopmental disorders, experience in this field with mouse models would be of particular interest. The successful candidate will be treated as an early career researcher and will be supported in applying for grants that will fund their position after the end of the contract.</p>

  - a. conduct recruitment process for the position specified in the above advertisement – as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
  - b. conduct recruitment process for the position specified in the advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator.
