Program / Project description	<p>The Symbiosis Evolution Group at the Institute of Environmental Sciences at the Faculty of Biology of the Jagiellonian University is looking for candidates for a 21-month position. The Assistant Professor will be employed within Polish National Science Centre (NCN) project "The evolutionary dynamics of the symbioses of Auchenorrhyncha", aiming to understand the factors and processes shaping the specialized symbioses of sap-feeding hemipterans. They will be responsible for bioinformatics analyzes of NGS data (analysis of amplicon data, genome assembly and characterization, comparative analysis of symbiont genomes, and phylogenomic analyses). 3. Your personal data will be processed in order to:
 - a. conduct recruitment process for the position specified in the above advertisement – as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
 - b. conduct recruitment process for the position specified in the above advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
