Project description	The successful candidate will work on an international, NCN-funded project to design programmable protein nanoparticles able to interact with tissues and viruses to achieve either virus capture or cell penetration. The candidate will be in charge of a project probing the

	effect of the three-dimensional arrangement of specific protein binders on a designed protein cage and understanding its interaction with the target virus. They will carry out and/or oversee relevant protein nanocage design and production, and attachment of externally mounted proteins. They will carry out the biophysical characterization of the resulting nanocages both before and after binding to the target. The research will be carried out in the laboratory of Bionanoscience and Biochemistry, located at the Małopolska Centre of Biotechnology (www.heddlelab.org) in the beautiful city of Krakow, Poland and will involve close interaction with colleagues in the UK and Slovenia. The candidates will work closely with the Centre for Programmable Biological Matter (CPBM) at Durham University UK Opportunities for travel including to the CPBM are anticipated.
