| Project Title | Long non-coding RNAs in human pluripotent stem cells |
| Project description | The successful postdoc candidate will work on an NCN-funded project to uncover the mechanism of action of selected human pluripotent stem cell-specific lncRNAs at molecular and cellular levels. Although over 170 000 human lncRNAs transcripts are reported in most recent releases of databases (e.g. NONCODE), only |

| | <p>a part of those RNAs has been attributed a biological function based on specific experimental studies reported in the literature. Moreover, their interaction with binding partners (e.g. proteins) and mechanisms of action underlying their cellular functions are still far from being well understood. There is also a shortage of experimental data concerning lncRNA structure. The Postdoc will apply genome-wide techniques to identify proteins and genomic areas bound by lncRNAs in human-induced PSCs and during their differentiation. He or she will work in close collaboration with the PhD student who will focus on the <i>in vitro</i> characterization of these RNAs using structural biology and biochemical approaches.</p> <p>The research group is based at the Malopolska Centre of Biotechnology, in the lively and international city of Krakow, Poland.</p> |

 - a. conduct recruitment process for the position specified in the above advertisement – as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
 - b. conduct recruitment process for the position specified in the advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator.
